- US\$ 375/- plus 18%GST (USD three hundred Seventy five only) per sq.mtr, on shell scheme basis for foregin exhibitors. (or Equivalent to Indian Currency)
- 10% extra for two side open booths.
- Discount @ 10% on published tariff on raw space without carpet & with electrical point for island only.
- Booking for Booths / Island will open on 9th August 2025 (09-08-2025).



Own Stands


